

**St. Rose of Lima School
Financial Agreement 2010-2011 School Year**

I desire for my child/children the religious education, individual attention, attentive caring, academic advancement, faith-filled perspective and Catholic values offered at St. Rose School. I will be involved in all aspects of my children's development and will abide by the regulations and directives set forth in the school handbook.

I understand that it will cost \$5,200.00 to educate a child at St. Rose of Lima School this school year. I understand that each child from St. Rose Parish receives a substantial scholarship from the Parish each year, and that remaining funds come from tuition and fundraisers. **The amount coming from the parish this year is \$1,700.00** for each child attending St. Rose School.

I also understand that Scrip and fundraising are expected to raise \$500.00 for each child this year and are integral components in keeping my tuition as low as possible. This agreement indicates the ways that I will contribute towards my child/children's education costs this year.

I understand that the 2010-2011 Registration fee is \$35.00 per student. I will pay this fee by:

Stewardship: I understand that each family is required to provide 20 stewardship hours during the 2010-2011 school year. I understand that I am responsible for providing documentation to the School in order to be credited for my stewardship hours and that \$20.00 per hour will be added to my tuition total for each stewardship hour I am short. I also understand that I may "buy out" of my family stewardship hours by paying \$400 by October 1, 2010.

Scrip: I will purchase \$1,000.00 worth of scrip this school year. (I realize this can be met with a \$50.00 purchase of groceries for 20 weeks.)

Fundraising: I will sell 7 lottery calendars at \$20.00 each. If I do not sell all 7 calendars I will have \$85.00 added onto my tuition which can be made in payment plan approved by the principal.

I will also assist in other fundraising activities. I realize I can earn back profit from various fundraisers including scrip which will be applied to my last tuition payment.

I understand the school reserves the right to contact a collection agency for any unpaid fees and that all fees need to be current to register for the following year.

I have been given a copy of the **School Tuition Payment Policy** and will abide by its requirements. St. Rose School relies on timely tuition payments to pay monthly expenses.

The School Tuition Payment Policy is (as stated in the handbook)...

I agree to pay a \$35.00 late fee for all tuition payments made after 20 days of the due date. I will contact the school administration promptly if it becomes necessary to revise the agreements set forth in this contract.

I understand that a credit check may become necessary to ensure the financial stability of the school. I have included my social security number for this purpose of collection efforts for past due accounts only. All information included in this contract will be held in strict confidence and seen only by the school administration or its finance designee.
